Preventing the spread of invasive species is an important responsibility for all Minnesotans, including lake service providers. Lake service providers are individuals or businesses who install or remove water-related equipment such as boats, docks, boat lifts or structures from waters of the state. State law now requires them to obtain a DNR permit. The DNR will implement and enforce the new requirement during the 2012 open water season. All service providers must complete invasive species training and pass an examination in order to get a permit. To do your part, when needing a lake service provider, make sure they have obtained the necessary permit. Those service providers with a permit can be seen at www.dnr.state.mn.us/lsp/index.html.

#### INVASIVE SPECIES COMMITTEE REPORT

Attended the 2012 MN AIS Symposium March 19th & 20th which covered the latest research on aquatic invasive species (AIS) management and the policy and legal implications of the approaches available today. Speakers included scientist, lawyers, professors, biologists, water shed districts managers, and DNR specialist, covering topic such as invasive aquatic plant control, selective control using herbicides, plant/fish interactions, non chemical plant control, research, status of control methods, impact on tourism and legal and policy issues regarding AIS management. It was well attended. In addition was able to meet and discuss with attendees common lake issues.

The AIS Symposium was held within a couple blocks of the State Capitol. This being an election year senators and representatives stop in covering current and past legislation. It seemed there is a high priority at the State Capitol to appropriate resources and funding to management and control AIS such as zebra mussels, Asian carp, Eurasian water milfoil, curly-leaf pondweed to name a few. Some examples given were hiring an additional 150 DNR public landing boat inspectors, purchasing 20 additional high pressurized boat/trailer spraying equipment, and doubling 2012 grant money to \$1.3 million for treatment of AIS. The next time you see your State Senator or Representative thank them for the support in protecting and preserve Lake Washington making them aware addition resources and funding is needed for this valuable resource.

Now back to earth. We have been working closely with the DNR to finalize the Lake Washington Vegetation Management Plan, which has been a work in process for over two years. Political wheels turn slowly. But with respect to managing Eurasian water milfoil, we will continue our strategy to chemically treat 70 acres on a rotational bases around the lake. A permit has been submitted to the DNR to treat 70 acres along with a grant/funding request (approx. \$10,500). Both the permitting and funding procedure has been simplified this year. Time will tell how effective this new procedure is.

One last point, this year the DNR Aquatic Invasive Species Group will be conducting two point intercept vegetation assessment in Lake Washington, one in May the other in August. This assessment defines vegetation types and quantities in our lake. It will be used to evaluate the effectiveness of the 2011 and 2012 chemical treatments of 70 acres of Eurasian water milfoil along with impact on native vegetation. The vegetation assessment is a major undertaking. A special thanks to DNR Invasive Species Specialist Nike Brown and Joe Eisterhold.

#### COMMUNICATIONS AND PUBLIC RELATIONS COMMITTEE

During the late fall and winter months, the Hutchinson DNR facilitates a discussion group the 2<sup>nd</sup> Tuesday of every month called Avid Anglers. The group consists of local anglers in McLeod and Meeker County and often attended by LWIA board members. The group meets informally to have open discussion about area lake issues, conditions, events, concerns, etc.. The DNR also uses this venue to table internal agenda items. The hot topic this season was the need to raise license fees to increase funding to the DNR as they consistently laments how they are understaffed, losing resources, and not adequately staffed. Recommendations were made to the DNR to ask for volunteers and/or contract temporary employees during peak activity periods. The DNR explained this would not work as volunteers are not consistent enough to make a significant impact and temp employees create a conflict with union employees. Do you see the contradiction? The DNR needs help but only under their conditions by increasing license fees to support more internal resources. Besides, public assistance/outside assistance would inevitably cloud or fragment the very control they wield when we, the customer, ask for help. Can you imagine a volunteer from our Invasive Species or Cormorant committee participating in the daily DNR activity?

This is the third year of the Meeker County Crime Alert communication process in collaboration with the Meeker County Sheriff's Office. Since our last newsletter in the fall of 2011, there were three crime alerts issued by the Sheriff's office:

1/19/2012 Burglary - Home burglary on the south side of Lake Stella

1/24/2012 Suspicious Activity – Drug and felony warrant arrests on the south side of Lake Stella

3/25/2012 Burglary - Home burglary on the south side of Lake Stella

#### CORMORANT/PELICAN IMPACT COMMITTEE

On Monday September 19<sup>th</sup>, a letter was mailed to area politicians requesting support in controlling the rising cormorant populations and impact on Lake Washington bait and game fish. We received responses from Senator Scott Newman and Representative Dean Urdahl supporting the LWIA request for the DNR to meet and continue discussing concerns. No response was received from Governor Mark Dayton, Senator Amy Klobuchar, Congressman Collin Peterson, or Senator Al Franken. A meeting was held on December 19, 2011 to cover the LWIA position on cormorants and pelicans. This meeting was attended by six DNR representatives from St Paul, New Ulm, Hutchinson, a Federal Wildlife Biologist and a Staff Writer for the Herald Journal. The lake side was represented by Ken Klehr, John Fink, Dean Shaner, Rick Fernstrom from Lake Washington, Marv Haugen from Belle Lake, and George Kraemer from Collinwood Lake. Despite the evidence presented, the DNR refuses to recognize there is a depletion of fish due to the increased cormorant population. To see the:

Our position is to keep the pressure on the DNR and advocate for a reduction in the cormorant population. As noted in the DNR response letter, the next Lake Washington fish survey has been moved up to 2012 from 2014 as a result of our concerns. This information will show any changes in fish population since the last fish survey in 2008. Efforts are also underway to spread the word/educate other lake association to further increase awareness and pressure for action.
