#### END OF THE DOCK

This year, the emphasis has been at State level on protecting lakes from Aquatic Invasive Species (AIS) and with that comes new laws and changes to existing laws and fines. To name a few:

- Beginning July 1, fines are doubling for transporting watercraft or equipment with attached aquatic plants from \$50 to \$100. For possessing or transporting a prohibited invasive species you are looking at \$500.
- Lake Service providers that repair, launch and store boats and install and remove buoys, docks and boat lifts are required to complete extra training, pass test and apply for a three year permit while employees must take an online training course and receive a certificate.
- Also Beginning July 1, boat lifts, docks, swim rafts and other water-related equipment (except boats and other watercraft) that are removed from any water body may not be placed in another water body for at least 21 days to kill invasive species that might be attached.
- You are to remove all aquatic plants and animals, drain all water and leave drain plugs out during transportation.
- Beginning July 1, 2015 boat owners will have to pass an online course on how to prevent the spread of aquatic invasive species before they can trailer their boats. Those hauling docks or boat lifts also will have to pass the course. The highlight of this is those completing the course will get a trailer decal that allow them to legally transport their boat (another decal).
- These laws are intended to stop the spread of Eurasian water milfoil, Asian carp, zebra mussels and other invaders. Please do your part in keeping AIS out of our lake.

We did get relief from the requirement of placing an AIS rules sticker on watercrafts. This is being dropped and being replaced with an online education program. So you will no longer be required to place on your boat the silver and black decals outlining the states AIS laws. To keep current on the laws access the following website:

The total cash position of LWIA as of June 30 is \$90,194. The decrease is the result of payment of \$31,850 for treatment of 70 acres of the lake at \$455 per acre. Revenue for 2012 memberships to date is \$10,000, representing 200 members. Invasive species donations from 2012 members total \$4,511 to date. There are no unpaid bills on hand as of June 30.

#### **INVASIVE SPECIES COMMITTEE REPORT**

If you have been out on the lake Eurasian water milfoil (EWM) and other aquatic vegetation is alive and doing well. Especially if you live on the north and south side of the lake you are being challenged with EWM drifting into your beach area. The majority of this EWM and other vegetation is piling up on the shore is a result of high winds and boat traffic going thru areas infested with EWM and native vegetation. There is not much that can be done with the winds but please avoid, with your watercraft, matted areas that have infestation of EWM or any other aquatic vegetation. This helps reduce the amount of vegetation on shorelines and reducing the spread of EWM to other parts of the lake. Also the native vegetation is good habitat for fish. Last put not least, this will be appreciated by your neighbors on the south and north sides of the lake that ends up hauling it away.

Per our Lake Vegetation Management Plan on **rotational bases** we will continue to treat each year 70 acres of EWM with focus on recreational activities such as boating, fishing, swimming, sailing, and tubing while protecting habitat for fish. Keep in mind that the cost for this treatment is over \$30,000. This year's treatment of 70 acres was completed on 6/7/2012. Our next effort will be to assess the effectiveness of this year's treatment and the areas treated in 2011. We will analysis this data to help develop next year's, 2013, treatment locations and strategy.

We appreciate your donations to the Eurasian water milfoil fund. Keep in mind, @ \$455/Acre and 70 acres at \$31,850; it is expensive to chemically treat for EWM. In addition to your donations we have been aggressively pursuing grant money at both state and county levels resulting in \$10,500 from the State and from Meeker County \$3500. So when you see your state or county representative say thanks and ask them to continue their support funding to combat AIS.


#### COMMUNICATIONS AND PUBLIC RELATIONS COMMITTEE

#### Recycling, Composting, and Waste By Steve Grotbo

A number of us like me are just here on the weekend to enjoy the lake. At the end of the weekend we load up our garbage in the trunk of the car and haul it home. Because we are only weekenders, it is not practical to have regular garbage pickup at the lake. For those times when we have exceeded the trunk capacity you have ways to reduce the load.

The Meeker County Transfer Station is located just north of Litchfield at 63645 293rd Street. The hours are M-F 9 AM-4:30 PM and Saturday 8 AM-noon. The cost is only \$6 for up to 200 lbs. of almost anything. They have rates specific items like TVs and appliances. You can also drop off your recycling at no charge, just be sure to do this part before driving on the scale.

In Dassel they have a self-serve recycle drop off that accepts glass, plastic, paper, cardboard, and cans. It seems to vary whether you have to separate glass by color or not. The location is the first right as you enter Dassel on Public Street just a block south of Hwy 12.

Next to the Cenex in Litchfield a self-serve station exists for getting rid of used motor oil and such.

Getting rid of yard waste is a bit trickier. If you can do your own composting, that is best. The Dassel compost site only allows city residents to drop off items, so folks on the lake are out of luck. You can however get compost from this site if you need to fill in areas. The Litchfield compost site is open to all and is located just south of Lake Ripley. The hours are M-F 11 AM-7 PM and Saturday 8 AM-4 PM. For those heading south, Hutchinson (<a href="http://www.ci.hutchinson.mn.us/composting.html">http://www.ci.hutchinson.mn.us/composting.html</a>) also has a compost site that is open to all.


#### **CORMORANT/PELICAN IMPACT COMMITTEE**

During April and May, the DNR Nongame Wildlife Program conducted surveys of nesting colonial water birds on Pigeon Lake. The survey showed a 9% increase in cormorant nests (pairs) and 122% increase in pelican nests (pairs) since the last survey in 2010. In bird numbers, that means 189 more cormorants and 662 pelicans. Since 2004, cormorant nests have increased by 55% and pelican nests have increased by 238%. These increases are staggering as more birds means higher fish consumption. In aggregate, the cormorant and pelican population has almost doubled since 2004 and there is no information reported that bird populations won't continue to grow.

In July, the DNR Fish and Wildlife Division will conduct a fish survey on Lake Washington. The results from this survey will be compared to the increasing bird population on Pigeon Lake and used to support the need for reducing the bird population on Pigeon Lake.

As you know by now, Governor Mark Dayton signed a bill on May 3<sup>rd</sup> 2012 to increase the cost of a 2013 resident fishing license from \$17 to \$22. That's an increase of 29%! The fishing license fee covers the expense of DNR stocking programs so indirectly, your license dollars support the increased food supply required by the rising bird population on Pigeon Lake. And if that doesn't make you angry, consider this. The weight of the total walleye fry stocked every other year by the DNR will feed a single cormorant nesting pair for only ~10 days or a single pelican nesting pair for only ~2 days. The DNR would not agree with this comparison. Conversely, during the DNR meetings over the past year to discuss the cormorant concern, the Hutchinson DNR attempted to downplay the concerns and produced a report stating fish consumption by other fish within a lake far exceeds the consumption by predatory birds. So there is no problem. But fish eating fish make bigger fish that produce more fish. Birds eating fish make bigger birds that produce more birds while reducing fish population. If we could only find a way to beat the cormorants at their own game, the concerns of over population would be reduced. Predators of cormorant eggs and chicks include gulls, crows, blue jay, common grackle, raccoon, red fox, and coyote. Adult cormorants are preyed on by bald eagle and great horned owl. To promote increased cormorant and pelican natural predation in the Pigeon Lake area, we need to 1) refrain from ground mammal trapping and hunting to allow populations to increase proportionately, and 2) develop a process whereby predatory ground mammals can naturally reach the two islands to control the cormorant and pelican population through natural predation. Keep it cheap, natural, and legal.
