This season started with water levels being very high to the point we had people requesting a no wake zone to be enforced when within 500 feet of shore like the Meeker County Sheriff did on Big Swan Lake. Now with the water level closer to a "normal" level it is raising concerns that it is heading to be a repeat of last season. The concerns have been heard and contact with DNR has been made.

The residential weed / swimmers itch treatment from Lake Restoration was delayed a few weeks with initial treatment being end of June. Many of the DNR permits were approved as expected in the four week period, but not all. I am just happy that the process moved forward this year and treatment from a third party was made available. Work was completed 6/30/22 and a report was received which will be included in the Fall Newsletter.. - ed.

# **New Washington/Stella Culvert Update**

The new culvert is still waiting for a DNR permit, which was supposed to be completed in April. Seems to be a pattern forming of a lot of wait time for DNR projects around the lake. Assuming DNR approves as designed, the project gets advertised for a month and then is awarded to a contractor.

Phil Schmalz (Meeker County) indicated that manufactures are dealing with a significant backlog which could also have an impact on the construction once a contractor gets the work. Of course, if the DNR comes back with something other than concurrence with the hydrologist study, that will delay things further.

## **Zebra Mussels**

Last summer we saw only one mussel on the hotels and saw very few reports of zebra mussels on docks and boat lifts. The low number of mussels last year could have been due to lower water levels and higher water temperatures limiting reproduction. One other possibility is Lake Washington's zebra mussels are moving out of the exponential population growth phase. Exponential growth usually continues as long as there is abundant food, colonizing locations, and low number of predators. Make your own call on the reason(s) for last summer's lower population. I'm thinking poor reproduction environment and increased predation.

Mike Wosmek installed the zebra mussel "hotels" (settlement plates) in the same locations as last year. We do clean the hotels every fall, so all zebra mussels on the hotels should be this year's crop. The hotels were installed Memorial Day weekend and will be picked up Labor Day weekend.

#### **Cormorants And Pelicans**

The pelicans seem very prevalent in April with groups of 75 of them coming in at one time. This was followed by a few weeks' break with the return in lower numbers. We are not having any luck at controlling the cormorant population with them being federally protected and official fish counts being high. So thought is can we at least take some action to reduce the pelican population?

I received the following information from Scott Mackenthun (DNR) on the subject of pelicans. American White Pelicans are similarly protected by the same act).

Right now, only Double Crested Cormorants are under consideration for control permits managed by states under the watch of the United States Fish and Wildlife Service. American White Pelicans are not. I've contacted Non game Wildlife Specialist Mike Worland to see if he has anything further to add regarding water bird management in Minnesota.

Moving on to discuss fish monitoring activities at the DNR:

Fish population monitoring activities have continued at a high frequency on Jennie, Collinwood, and the Washington Chain. To date, we have not seen fish populations deviating from their range of normal values.

For respective lake class types. I note that the Washington Chain has seen the fish community change but much of it is likely the result of changing habitat conditions associated with increased water clarity following zebra mussel introduction. As the zebra mussel population has declined of late, I'm anxious to see how the fish community responds and what a "new normal" might look like.

I feel fortunate that we've been able to collect more data as the result of Water Bird Impact Committee meetings with myself and predecessor Lee Sundmark. It's been helpful tracking year class fates and seeing how species abundance fluctuates between years. Of late the Water Bird Impact Committee has operated in an ad hoc fashion, communicating results and updates as they come via email – be them legal or scientific, from USFWS or DNR, etc. I'd propose continuing in that fashion. I appreciate the work and interest of the group and will continue sending information as best I can.





# **Water Quality**

**Lake Water:** This summer we have added water temperature tests to our twice a month water clarity tests. These new temperature readings will also be input to the MN Pollution Control Agency in the fall. We also have added temperature to the LWIA web site after testing, although we are still working on the best format to present the data. The water temperature is being taken at all 5 tests sites. So far the temperature at site 101 is within a couple of degrees of the other four sites.

With the drought conditions we experienced last year, we have provided a link to the DNR lake water level graph on our web site. As of this writing, we are again having drought conditions. Per the US Drought Monitor, Meeker County is abnormally dry.

We have taken 2 lake water samples already this year and will do 3 more all from site 101. Each sample will measure the amount of algae (Chlorophyll-a) and nutrients (Total Phosphorus) in the water. The analysis is again being performed by RMB Environmental Labs out of Detroit Lakes, MN. I don't have test results yet from the samples pulled in May and June. RMB has a nice website, RMBEL.info, where you can view Lake Washington past test results as well as other Minnesota lakes. Our data can be found under Lakes Monitoring Program in the Lakes & Streams drop-down menu. Then under Lakes Database.


#### **Water Test Sampling Sites**

We are also conducting water clarity tests twice per month at 5 different sites (101, 205, 207, 208, & 209). The water has been clearer this year than some of the years in the past. In May the average depth we could see the secchi disk was 10.33 feet. In June the average depth was 7.83 feet. At the end of the summer all data collected will be submitted to the Minnesota Pollution Control Agency. They also have a website where you can view our Lake's data at <a href="mailto:pca.state.mn.us">pca.state.mn.us</a> although it takes a bit of "drilling down" in their website.

# **Water Quality (continued)**

**Inlet Water:** We are planning also this year to test some of the inlet water (up to 6 inlets) coming into the lake. These tests will be weather dependent, as we will need enough rainfall during the summer to get sufficient water flow. This year we would like to grab samples following a larger rainfall to get an idea of the amount of suspended solids flowing into the lake from selected inlets.

Early this spring before the frost was out of the ground, we got a 3 inch rainfall (at least from my rain gauge). Because the ground was frozen, most of the rain falling in the Lake Washington watershed runoff and filled the area lakes. The water level after that 3 inch rain was even higher than normal for Lake Washington. Approximately 4 to 5 inches higher than normal, based on the MN DNR lake level graph. We are awaiting a report from Ethan Jansen, MN DNR area hydrologist regarding recent lake levels.



# Lake Washington Weather Underground Stations

Currently there are 4 stations on Lake Washington. I have had my weather station (positioned on the peak of my house roof) for a year now. I am impressed on its accuracy with temperature, wind and precipitation amounts. I like looking at the other stations to see if the area gets different amounts of rain. The model I have is Logia 7-in-1 Wi-Fi Weather Station with Solar | Indoor/Outdoor Remote Monitoring System (\$159) on Amazon. They have many models to choose from. At this time, I have not had to replace batteries (says it last up to 2 years).

# Watercraft Inspection

We again installed the I-LIDS system (Internet – Landing Installed Device Sensor) on the East side of the ramp at Ellsworth Landing. Installation of the system took place May 4<sup>th</sup> and will be removed in the October/November time frame depending on weather conditions. We received a new Special Use Permit from MN DNR Parks and Trails on February 10<sup>th</sup> of this year for the installation of I-LIDS at Ellsworth Landing. The permit is good through the summer of 2024. We have contracted with Environmental Sentry to review up to 3,000 videos. As of this writing we have reviewed 695 out of approximately 2900 videos captured by I-LIDS.

We believe the I-LIDS system has been effective in improving boater compliance to MN DNR rules regarding boat decontamination prior to launching and prior to leaving the landing, especially during times when watercraft inspectors are not at the landing. Boaters are reminded via audio messages to clean weeds and debris from their boats, as well as drain their boat, livewells and baitwells, keep all drain plugs out while traveling, and dispose of unwanted bait in the trash.

Meeker County and MN DNR has been doing watercraft inspection and decontamination as they did last year at Ellsworth Landing mostly on Thursday, Friday, Saturday, and Sunday.



# Minnesota Lakes and Rivers Advocates (MLR) Initiating a "Lake Steward" Program

Minnesota Lakes and Rivers Advocates (MLR) developed Lake Steward in response to the decline of lake health in Minnesota. Lake Steward gives property owners clear and specific steps they can take to improve the health of the lake they love. A lake association volunteer, training by Minnesota Lakes and Rivers Advocates, and expert advice from the Shoreland Guide to Lake Stewardship give property owners the support and direction they need to improve lake health, particularly in front of their place.

Lake Washington is currently hosting the Lake Steward Program through Minnesota Lakes and Rivers Advocates. This program helps our lake association members self assess their property to make sure we are all protecting our lake as best we can. The Lake Steward Program has been successful in protecting over two and half miles of shoreline within the first two years of its operation - we hope that our lake association can inspire our members to protect additional miles of shoreline in Minnesota.

Lake Washington has been a member of the Minnesota Lakes and Rivers for many years. We encourage you to take the self-assessment at the following link which is just 13 questions. The results are also sent back to the Lake association. This link also provides more information about the program:

If you feel that you are a good Lake Steward, feel free to contact Steve Grotbo (651-335-8623) to have a more formal evaluation. Basically Steve has the app on his phone and can run through the Q & A to get your property evaluated. If your property qualifies you can request a sign for your yard that also includes Lake Washington's logo. The cost of the sign is around \$46 where you pay half and Minnesota Lakes and Rivers pays the other half.

# Aquatic Invasive Species By Mark Johnson, AIS Coordinator

Keep an eye out for this invasive. Starry Stonewort is an invasive alga that was first discovered in the United States in the St. Lawrence Seaway in 1978. In Minnesota, the first confirmed infestation was Lake Koronis, Stearns County in 2015. Since then 12 other Minnesota lakes have been confirmed infested. Starry Stonewort looks like Native Chara, Native Nitella, Sago Pondweed and Water Stargrass (all found in Lake Washington) - making this invasive difficult to identify. The most visible identifier is the white star like bulbil within the grassy plant. If you think that you have identified this invasive in Lake Washington, please contact the Lake Washington Improvement Association at info@lwiaonline.com for evaluation and we can report it to MNDNR AIS Specialists through their reporting app. **Remember**, the most common way that aquatic invasive species get introduced into new bodies of water is from boats and other recreational equipment moved lake to lake. Therefore, boat landings and areas around docks are locations where this may first appear. Please help stop the spread of Aquatic Invasive Species!



#### <u>Vegetation surveys planned for Lake Washington this summer.</u>

At the time of writing this article, we have yet to be on the lake to perform vegetation surveys. Ron Bubany, Mike Wosmek and I will be out later in June and in July searching for aquatic invasive species. As we did last year, our plan is to focus our vegetation surveys near the shorelines in search of new growth clumps of Eurasian Watermilfoil and random waypoints where we have identified traces previously. In addition, we will look at our boat landings for Starry Stonewort.

Later this summer, LIMNOPRO Aquatic Science will be on Lake Washington to conduct an Aquatic Invasive Species Early Detection Survey. This survey looks at 20 random waypoints across the whole lake plus at all three boat landings and the inlet from Lake Stella. They look specifically for Eurasian Watermilfoil and Starry Stonewort. The results of this survey will be published in our fall newsletter. See you on the lake!
